FEES:

Application forms must be completed annually and returned to the Accounts Office with a R250.00 non-refundable application fee.

Fees are payable monthly in advance.

The late or non-payment of fees will result in suspension from the Aftercare facility.

SECURITY:

A register is kept, and all learners **MUST** report their arrival at Aftercare facility **every day**.

For the safety of the learners, parents are required to collect the child from the Aftercare area and sign the register before leaving every day. Children will not be allowed to sign themselves out.

Parents are **not** to request via phone call that a child be sent to the entrance of the Centre for collection. Bridge Edu Centre and its staff cannot take responsibility for a child once the child was signed out.

No child will be allowed to wait outside the Centre.

Late pick-up (17:01 and later will result in a late pick-up fee of R 50.00).

Should your child visit a friend or be collected by someone other than the child's biological parent/s or guardian/s, the parent/guardian is to advise the Aftercare staff beforehand as no child will be allowed to leave the premises with any other person not known to the staff unless the staff have been notified.

Parents must notify the Aftercare in the event of the child/children not attending for any reason, including illness, etc.

Homework is supervised and is compulsory for all.

There are no facilities for a sick child and therefore parents of a sick child will be contacted to collect their child immediately.

All lost/left articles are placed in the lost property box and parents should search for lost/left articles there. PLEASE MARK ALL ITEMS CLEARLY FROM THE SCARF TO THE SOCKS.

CELL PHONES:

All cell phones **MUST** be handed in when signing into Aftercare for safe keeping. Use will only be permitted once homework has been completed.
