Dear Prospective Parent / Guardian,

We would like to thank you for considering **BRIDGE FET Edu Centre** as an Educational Facility for your child.

All students enter BRIDGE FET Edu Centre on a 1-year (3 months) trial / probation period. The Educational Centre reserves the right to terminate a student's placement if the principal feels that a student is not benefiting from the educational system offered by **BRIDGE FET Edu Centre**.

We aim at providing quality education.

Bridge FET Edu Centre offers the home school student full-time, face-to-face tutoring using the GED Curriculum for the Senior Phase student and the Myonlineschool GED-Prep for the Intermediate Phase student, Grade 6-9.

Bridge Edu Centre aims to provide quality teaching in a stimulating, nurturing, and safe learning environment.

We cannot guarantee the success of any student who DOES NOT give their full co-operation.

- **Enrolment/Registration:** On formal acceptance into our Educational Facility, a once-off non-refundable registration fee of R 4,750.00 for the GED Curriculum and R 6,000.00 for Myonlineschool must be paid to **BRIDGE FET Edu Centre** strictly within 7 days after receiving an acceptance email along with an invoice.
- The enrolment fee will be valid for a period of 12 months. The enrolment fee will be forfeited if the student is enrolled but does not show up.
- On completion of this form, the parent/s / guardian/s take full responsibility for the payment of educational fees.
- The completion of this application serves as evidence that the parent / guardian understands that the educational fees should be paid monthly **IN ADVANCE by the 3rd day of each month**. 2% Interest per month will be charged on all outstanding fees.
- **For the account to stay in balance it is advised that an additional payment be made during the month of January.**
- Should the annual fee be paid in full, by 31 January 2024, a 5% discount will apply on the full annual amount. Should the child leave the Educational Facility prior to the completion of the 12-month period, the discount applied for the previous months will be forfeited, and the full monthly fee will apply retrospectively, and the balance refunded to the parent over a three-month period.
- **Application forms do not automatically guarantee acceptance.** We will notify you formally once a final decision has been made by management.
- **Non-payment of educational fees** will result in your child not receiving further tuition until your account is up to date. The student's online profile will be blocked until full was received. **BRIDGE FET Edu Centre** is an independent and private tutoring centre. We rely on educational fees to be paid in advance for the smooth running of the facility.
- **Payment of your monthly account cannot be made subject to a third party. i.e. SARS pay-out, trust-fund pay-out, divorce proceedings underway or any other entity or reason. Account Holder remains liable for monthly payments until a third party pay on their behalf.**
